From CAN to CAN SME

After a successful implementation of low carbon methods and solutions at the local scale, the CAN project took a new direction last year. The innovative activation approaches for energy retrofits in Northwest European neighbourhoods inspired the partnership to continue on this pathway. In fact, further needs and opportunities were identified in the economic sector and that is why the project idea was expanded to include a new target group: small and medium-sized enterprises (SME). Since the beginning of the capitalisation initiative of CAN in March 2021, the partners are working hard to reach and motivate SMEs to take energy saving measures, based on the lessons and experiences of the past years. The activation of the new target group presents a lot of challenges, especially in times of the Covid-19 pandemic and that is why the transnational exchange is crucial!

The current consortium is composed by Climate Alliance, Liège, Brest metropole and Worms, supported by Arnhem and the Energieagentur RLP. Also a brand new partner joined the team, the 3 Counties Energy Agency (IR).

Newcomer: 3 Counties Energy Agency

3 Counties Energy Agency joined the CAN project as a new partner in 2021. The nonprofit independent energy agency supports the counties of Kilkenny, Carlow, Wexford, Waterford, and beyond to reduce its CO2 emissions by stimulating, driving, and contributing to the implementation of best practices in the field of energy efficiency. Using its network and expertise, 3cea launched an application for SMEs from different sectors to get a tailored energy audit. Around 30 SMEs already applied for the audits.

advices on energy saving measures, e.g. via pop up energy advice desks and events. Ever since, ESC continues to run energy desks and pays more attention to specific sites in order to better reach vulnerable people. In response to the COVID pandemic, ESC adapted its services and launched a telephone energy advice as well as a home delivery of energy saving measures.


