Three student teams from Hamburg, Stuttgart and Aachen, each with an innovative and sustainable business plan, competed on 08 July in the German G-BiB semifinal. The expert jury members Prof. Dr. Detlev Riesner, European business angel and founder of Qiagen, Tobias Faupel, investment manager at the High-Tech Gründerfonds, Achim Roth, leader of the 2nd Chemical Division, and Mustafa Oezbir, biofuels trader, both at Mitsui & CO Deutschland, challenged the teams with questions after their pitch and then discussed to decide, that LignoPure from Hamburg and EBS from Stuttgart will have the chance to win the final award during the international final.
